Mentors

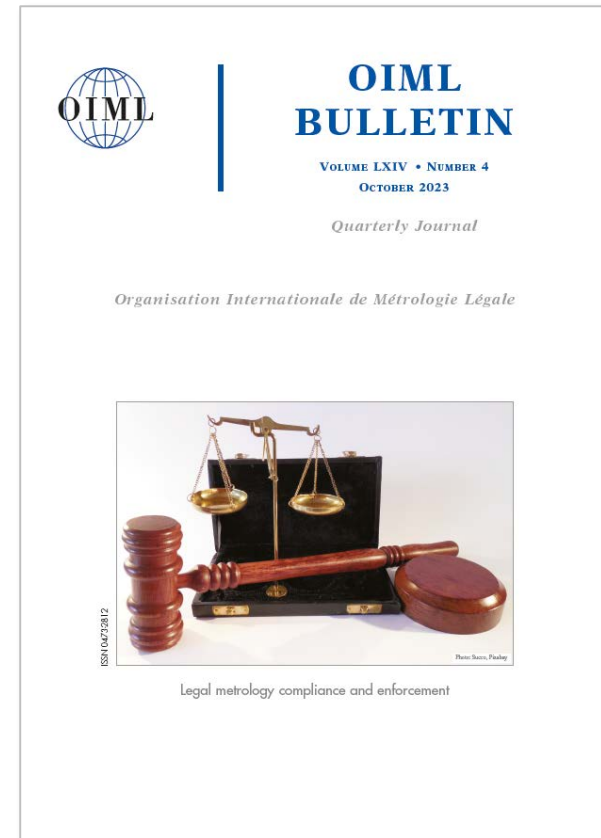
- ‘**Mentors**’ take responsibility for certain key topics

- The ‘Mentor’ concept has been very successful again this year
 - The concept was launched at the 54th CIML Meeting in Bratislava (2019) by the CIML President – 2024 is now the **5th year**
- It has now become the key mechanism for developing the Bulletin’s content
- At the 57th and 58th CIML Meetings the CIML reiterated its support for the ‘Mentor’ concept, and four editions of the Bulletin have been produced since then on a variety of themes

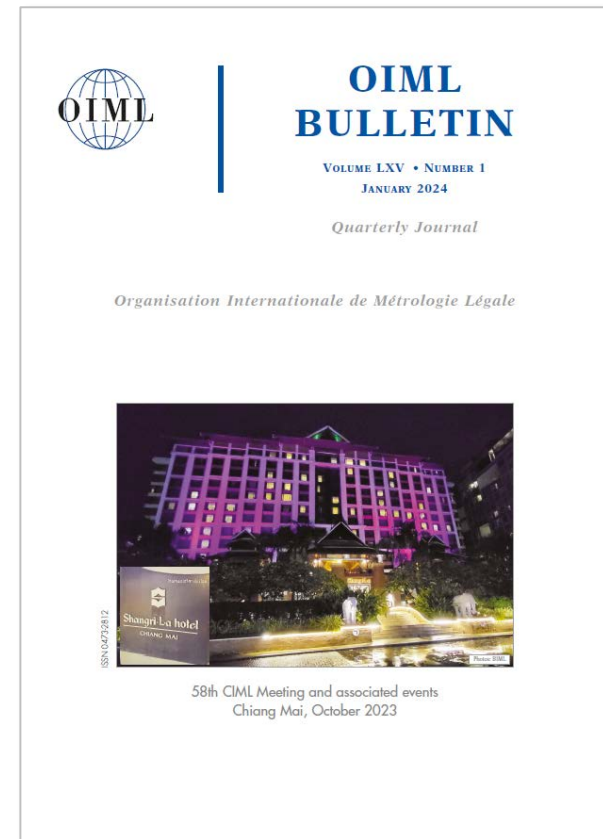

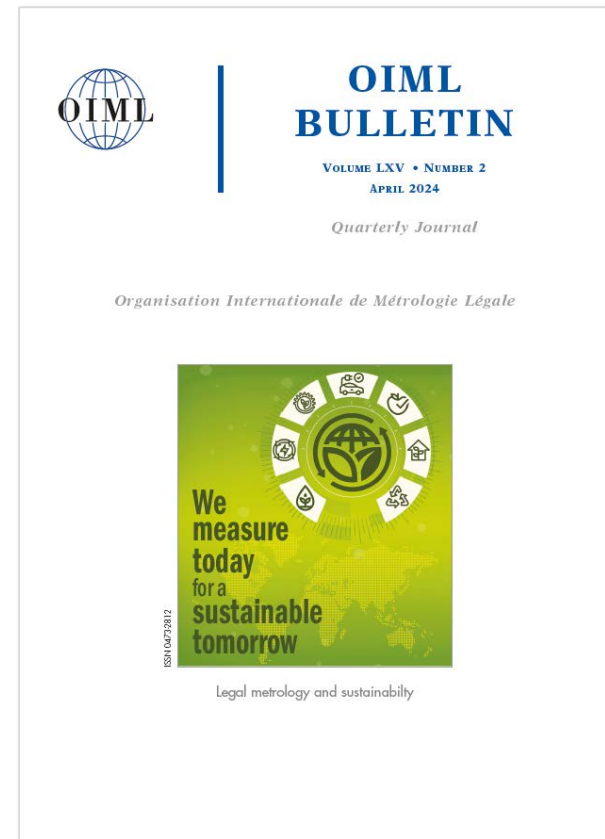

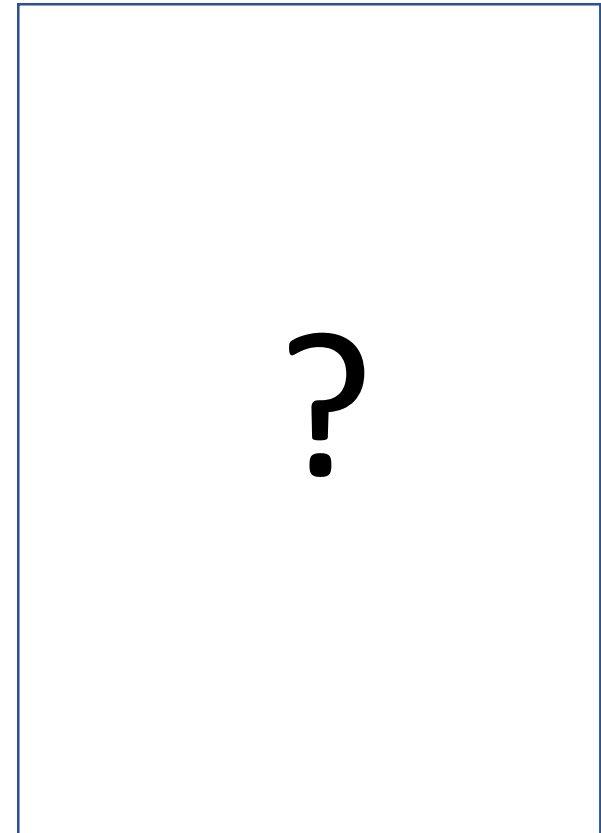
